

## DBS eDDA Transfer in Service Promotion ("Promotion") Terms and Conditions:

- 1. The Promotion shall run from 29 June 2022 to 13 November 2022, both dates inclusive ("**Promotion Period**").
- The Promotion is only applicable to customers ("Customers") of DBS Bank (Hong Kong) Limited (the "Bank") who hold an account with DBS Treasures or DBS Account ("Eligible Accounts"). To participate in the Promotion, Customers must maintain the Eligible Accounts until 13 January 2023.
- 3. **"DBS Treasures**" and **"DBS Account**" are customer segments of the Bank. **"Customer Segment**" means DBS Account, DBS Treasures, DBS Treasures Private Client, DBS Private Bank and any other segment made available by the Bank from time to time. In Hong Kong, DBS Private Bank is the private banking division of the Bank.
- 4. **"Eligible Transaction**" means successfully linking other local bank account to DBS account to set up an Electronic Direct Debit Authorization ("**eDDA**") service and conducting a fund transfer in via eDDA on DBS digibank HK app to the Eligible Accounts.
- 5. Customers who have completed the Eligible Transaction(s) with an aggregate fund transfer in amount of HK\$2,000 or above during the Promotion Period will be eligible to receive the corresponding rewards set out in Table 1 below:

- The Cash Reward will be credited directly to eligible Customer's HKD Current Account under the Eligible Account on or before 13 January 2023. If the Customer wins the Prize, the Prize will be credited directly to eligible Customer's HKD Current Account under the Eligible Account on or before 13 January 2023.
- 7. Customer must maintain a valid HKD Current Account under the Eligible Account at the time the Bank credits the Cash Reward and Prize.



- 8. The Lucky Draw shall be drawn randomly by the Bank and the results will be announced instantly on the Promotion website go.dbs.com/hk-edda2022-en. The Bank's records as to whether a Customer is eligible for entry shall be final and conclusive.
- 9. Each Customer can only enjoy the Promotion and enter the Lucky Draw once. For the Lucky Draw, the first successful Registration shall prevail, any subsequent Registration under the same registration information will be treated as invalid.
- 10. The Cash Reward and Prize are non-exchangeable. The Bank can replace the Cash Reward and Prize with alternative rewards without prior notice.
- 11. Only primary account holder is eligible to the Promotion.
- 12. Eligibility of any registration/ transaction for the purpose of this Promotion shall be determined based on the Bank's record. If there is any discrepancy between the Bank's record and the Customer's record, the Bank's record shall prevail.

Participation in the Promotion is subject to there being no abuse/non-compliance by the Customer, failing which the Bank will not credit the Cash Reward and Prize or where it has been credited, the Bank may debit the value of the Cash Reward and Prize from the account without notice and/or take such action to recover any outstanding amounts.
- 14. The Bank may change the terms and conditions and/or modify/terminate the Promotion without notice. The Bank's decision is final.
