

Terms and Conditions for DBS/POSB Credit Cards Activation S\$20 Cash Rebate Promotion ("Promotion")

1. The **Promotion** is from 7 August 2017 to 8 September 2017, both dates inclusive ("**Promotion Period**") and is only applicable to selected DBS/POSB Credit Cardmembers ("**Cardmembers**") who received the Activation SMS for their migrated ANZ Credit Card account(s).
2. The first 80,000 **Cardmembers** who successfully make three eligible transactions ("**Eligible Transactions**") on their newly issued DBS/POSB Credit Card (for their migrated ANZ Credit Card account) ("**Card**") within the **Promotion Period** ("**Qualified Cardmembers**"), will be entitled to a S\$20 Cash Rebate ("**Cash Rebate**").
3. **Eligible Transactions** include local and foreign retail transactions, posted 0% interest-free monthly instalment plans, recurring bill payments, cash withdrawals, balance transfers and monthly instalments of instalment loans, but excludes interests, finance charges, late charges and unposted/cancelled/disputed/refunded transactions and all fees charged by DBS.
4. **Cash Rebate** will be credited into the **Qualified Cardmembers' Card** account within 3 months from 8 September 2017.
5. A **Qualified Cardmember** can receive a maximum of one **Cash Rebate** for each **Card**.
6. **Eligible transactions** can be accumulated on both principal and supplementary **Cards**.
7. The **Cash Rebate of a Card** shall be forfeited if the **Card** account is terminated or suspended during the **Promotion Period** or within 3 months after the **Promotion Period**.
8. The **Cash Rebate** is non-exchangeable, non-transferable and non-replaceable.
9. Cardmembers consent under the Personal Data Protection Act (Cap 26 of 2012) to the collection, use and disclosure of the Cardmembers' personal data by/to DBS and such other third party as DBS may reasonably consider necessary for the purpose of the Promotion, and confirm that they agree to be bound by the terms of the DBS Privacy Policy, a copy of which can be found on.
10. DBS may vary these terms and conditions of or suspend or terminate the **Promotion** at any time without any notice or liability to any party. DBS will not be obliged to enter into any correspondence on any matter concerning the Promotion.
11. These terms and conditions shall be read in conjunction with the DBS Cards General Promotions Terms and Conditions and DBS Card Agreement. In the event of any inconsistency, these terms and conditions shall prevail insofar as they apply to the Promotion.
