

**DBS eDDA Transfer in Service “Get Rewarded with Transfer In” Promotion (“Promotion”) Terms and Conditions:**

1. The Promotion shall run from 14 November 2022 to 31 March 2023, both dates inclusive (“**Promotion Period**”).
2. The Promotion is only applicable to customers (“**Customers**”) of DBS Bank (Hong Kong) Limited (the “**Bank**”) who hold an account with DBS Treasures or DBS Account (“**Eligible Accounts**”). To participate in the Promotion, Customers must maintain the Eligible Accounts until 31 May 2023.
3. “**DBS Treasures**” and “**DBS Account**” are customer segments of the Bank. “**Customer Segment**” means DBS Account, DBS Treasures, DBS Treasures Private Client, DBS Private Bank and any other segment made available by the Bank from time to time. In Hong Kong, DBS Private Bank is the private banking division of the Bank.
4. “**Eligible Transaction**” means successfully linking other local bank account to Eligible Accounts to set up an Electronic Direct Debit Authorization (“**eDDA**”) and successfully conducting a fund transfer in via eDDA on DBS digibank HK app to the Eligible Accounts.

5. Customers who have completed an Eligible Transaction during the Promotion Period will be eligible for **either** one of the following offers:
  - i) **New Users** are defined as Customers who have **NOT** completed ANY Eligible Transaction since 1 June 2022:

Completed a single Transfer in via eDDA with the following amounts	Cash reward (“ <b>Cash Rewards</b> ”)
HK\$1,000 to below HK\$10,000	HK\$100
HK\$10,000 or above	HK\$200

; or

- ii) **Existing Users** are defined as Customers who **have completed** ANY Eligible Transaction since 1 June 2022:

Completed a single Transfer in via eDDA with the following amounts	Cash reward (“ <b>Cash Rewards</b> ”)
HK\$10,000 or above	HK\$50

For the avoidance of doubt, the amount of cash reward will be given based on the first Eligible Transactions made by Customers during the Promotion Period.

6. The Cash Rewards will be credited directly to Customers’ HKD Current Account of Eligible Accounts on or before 31 May 2023.
7. Customers must maintain a valid HKD Current Account of Eligible Accounts at the time the Bank credits the Cash Reward.

8. Each Customer can only enjoy one of the offers as listed in Clause 5 once.
9. The Cash Rewards are non-exchangeable. The Bank can replace the Cash Reward with alternative rewards without prior notice.
10. Only primary account holder is eligible to the Promotion.
11. Eligibility of any registration/ transaction for the purpose of this Promotion shall be determined based on the Bank's record. If there is any discrepancy between the Bank's record and the Customer's record, the Bank's record shall prevail.
12. Participation in the Promotion is subject to there being no abuse/non-compliance by the Customer, failing which the Bank will not credit the Cash Reward or where it has been credited, the Bank may debit the value of the Cash Reward from the account without notice and/or take such action to recover any outstanding amounts.
13. The Bank may change the terms and conditions and/or modify/terminate the Promotion without notice. The Bank's decision is final.
14. Promotion information will remain accessible up to one week after the end of the promotion.
15. The English version shall prevail if there is any inconsistency between the English and Chinese versions.
