

## DBS FPS Registration Campaign 2024 ("Promotion") Terms and Conditions:

- The Promotion is only applicable to customers who hold a DBS Treasures account or DBS Account ("Eligible Accounts") on 31 July 2024 with DBS Bank (Hong Kong) Limited (the "Bank") and maintain the Eligible Account until 31 October 2024 ("Customers").
- 2. "DBS Treasures" and "DBS Account" are customer segments of the Bank. "Customer Segment" means DBS Account, DBS Treasures, DBS Treasures Private Client, DBS Private Bank and any other segment made available by the Bank from time to time. In Hong Kong, DBS Private Bank is the private banking division of the Bank.
- 3. The Promotion shall run from 16 April 2024 to 31 July 2024 ("**Promotion Period**").
- 4. Customers who fulfill the below requirements during the Promotion Period will be eligible to HK\$100 cash reward ("**Cash Reward**"):
  - i) successfullyregister for Faster Payment System ("**FPS**") on DBS iBanking or DBS digibank HK app; and
  - ii) set the Eligible Account as the FPS default fund receiving account for the first time; and
  - iii) maintain Eligible Account as the FPS default fund receiving account until 31 July 2024; and
  - iv) fund in a cumulative amount of HK\$10,000 or above (or equivalent) via FPS from other local bank account to the Eligible Account.
- 5. <u>Customers who have previously set the Eligible Account as the FPS default fund receiving account</u> on DBS iBanking or DBS digibank app during the period from 1 January 2024 to 15 April 2024 will be ineligible for the Cash Reward.
- 6. Each Customer is eligible to enjoy a maximum of HK\$100 Cash Reward during the Promotion Period under the Promotion.
- The Cash Reward will be credited directly to eligible Customers' HKD Current or Savings Account or Multi-Currency Savings Account under the Eligible Account on or before 31 October 2024 ("Fulfillment Period").
- 8. Customers must maintain a valid HKD Current or Savings Account or Multi-Currency Savings Account under the Eligible Account at the time the Bank credits the Cash Rewards.
- 9. Each Customer can only enjoy the Promotion once.
- 10. Only primary account holder is eligible to the Promotion.
- 11. Bank staff cannot participate in the Promotion.



- 12. Eligibility of any transaction for the purpose of this Promotion shall be determined based on the Bank's record. If there is any discrepancy between the Bank's record and the Customer's record, the Bank's record shall prevail.
- 13. Participation in the Promotion is subject to there being no abuse/non compliance by the Customer, failing which the Bank will not credit the Cash Rewards or where it has been credited, the Bank may debit the value of Cash Rewards from the account without notice and/or take such action to recover any outstanding amounts.
- 14. The Bank may change the terms and conditions and/or modify/extend/terminate the Promotion without notice. The Bank's decision is final.

- 16. Promotion information will remain accessible up to one week after the end of the Promotion.
