

Terms & Conditions

digibank Reward Points/Mileage Redemption and Blibli E-Voucher Usage

- 1. Blibli E-Voucher ("E-Voucher") can be used with minimum transaction on the Blibli Website or Applications which is equivalent to the Blibli E-Voucher amount + IDR1,-. exclude shipping cost.
- 2. Customers can redeem digibank Reward Points/Mileage with Blibli E-Voucher via digibank by DBS Application or DBSI Customer Centre at 08041500327 or +622129852888 (from overseas) by following the applicable terms & conditions.
- 3. E-Voucher is valid at least 1 month from the rewards/mileage redemption date. If the customer has not done any transaction within a month and E-Voucher is expired, customers can not request an extension of E-Voucher validity period.
- 4. E-Voucher cannot be used If the digibank Credit Card Customer who receives E-Voucher makes a purchase of less than the minimum value of E-Voucher transaction. Therefore, the digibank Credit Card Customer who has received E-Voucher is required to make purchases of or more than the minimum required E-Voucher transaction value.
- 5. E-Voucher cannot be cashed or traded.
- 6. E-Voucher is valid for purchasing all products in Blibli, except cigarettes, lighters, and infant formula under 1 (one) year.
- 7. E-Voucher is valid for payment using digibank Credit Card.
- 8. E-Voucher is valid for a customer that have verified account in Blibli.
- 9. E-Voucher is only valid for one time transaction, does not apply to multiples
- 10. E-Voucher cannot be combined with other ongoing promo in Blibli website or applications.
- 11. E-Voucher cannot be used simultaneously (stacked) or separately.
- 12. Product purchases on Blibli must follow the terms and conditions of the Blibli Official Website and Applications.
- 13. E-voucher can be transferred or distributed by DBS to its affiliates or employees or DBS customers or other third parties.
